**Important Notices:** Creighton Livestock Market is located within a Brand Inspection Area. – Nebraska Brand Laws will apply.

- Items will be sold by how they are unloaded.
- Animals will sell with cages by the head – No Cardboard Boxes.
- All cages and their closures must be secured.
- Animals must be Fed and Watered Daily by Owner!
- Animals must be able to stand & not overcrowded & visible.
- Miniature Ponies & Donkeys will be sold.
- No Cats, No Dogs, No Saddle Horses, No Loose Horses.
- No Pigs over 3 months old - pigs must be in cage.
- No cervids can be sold (whitetail deer, mule deer, red deer, elk, etc.).
- No wildlife and no reptiles.
- Any cages or boxes in poor condition, or sick animals will be rejected at loading dock.



**ALL SALES ARE FINAL – ALL GUARANTEES ARE BETWEEN BUYER & SELLER.**

**Nebraska State Law requires** a Certificate of Veterinary Inspection and permit number for all birds and animals coming into the State of Nebraska. An entry permit for out-of-state sellers is available at no charge by calling 402-471-2351. State law no longer allows us to do pullorum-typhoid testing at sale site. All sheep and goats must have a scrapie tag. If not, one will be provided for a \$2.50 per tag charge.

**A vet will be available** at the sale if out-of-state buyers need health papers to exit the state. All birds are required to have a negative pullorum-typhoid test to leave the State of Nebraska. This testing documentation needs to accompany the birds out of the state and must have been done prior to the sale.

**\*Nebraska Sellers & Buyers\***  
Health Papers are not required on poultry and fowl.



**NEBRASKA STATE LAW requires Health Papers** on all hoof stock (cattle, goats, sheep, pigs, horses, mules, llamas, etc.) being sold by Nebraska sellers for the animals to enter the sale. A vet will be on site to issue health papers at \$25.00 per consignor/buyer, or the paper may be issued by your personal veterinarian no more than 10 days prior to the sale.
